* Qualifying CDS students' weekly tuition is \$10.00 plus CDS Copayment.

Weekly tuition includes lunch, snack, and entrance fee to the field trip activities. Tuition payments are paid weekly or by session and always in advance. Your child will not participate in the Summer Camp activities if the tuition is not paid in advance. Payments not received by Monday will be assessed a \$20.00 late charge fee. A \$35.00 charge will be added to your account for any returned checks.

Campers are required to wear closed toe shoes every of the camp. No crocs or sandals are allowed during camp days for safety reasons. Campers are expected to: 1) bring a refillable water bottle, 2) apply sunscreen bug spray at home, 3) hat and/or sunglasses for every field trip as needed. A change of clothes is optional, but may be a good idea.
